

# Articles 6.1 and 6.2 States Parties recognize that every child has the inherent right to life.

How could you take action to support or raise awareness of the right to life of the child. 6.2 States Parties shall ensure to the maximum extent possible the survival and development of the child. What can states do to ensure the survival and development of the child? What obstacles might states face in trying to ensure the survival and development of the child?

## Article 7.1

The child shall be registered immediately after birth and shall have the right from birth to a name, the right to acquire a nationality and, as far as possible, the right to know and be cared for by his or her parents.

# Article 8.1


States Parties undertake to respect the right of the child to preserve his or her identity, including nationality, name and family relations as recognized by law without unlawful interference.

## Article 9.1

States Parties shall ensure that a child shall not be separated from his or her parents against their will, except when competent authorities subject to judicial review determine, in accordance with applicable law and procedures, that such separation is necessary for the best interests of the child. Such determination may be necessary in a particular case such as one involving abuse or neglect of the child by the parents, or one where the parents are living separately and a decision must be made as to the child's place of residence.
